### The Vision

A new campus on Mull will

Innovation will be central to a new campus on Mull and it will promote and support partnership working with service providers, employers and community partners for the benefit of our young people and adult learners to be successful in gaining local employment and contributing to the local island economy. It will use local materials and have a low carbon footprint with reduced revenue, operational, repair, and maintenance costs.

A new Mull Campus will be the heart of economically thriving and connected communities that are welcoming, diverse and outward looking and will attract more people to live and work here.
